Decennial Census Data has Multiple Policy and Funding Purposes for Pennsylvania

MIDDLETOWN, Pa— The data collected by the United States Decennial Census is essential to Pennsylvania in many ways including in the formulation of public policy and funding distribution.

The Pennsylvania State Data Center at Penn State Harrisburg reports that, from the past five state legislative sessions (1991-92 through 1999-00), 65 Senate and House bills have been identified that require the use of census data to carry out the proposed legislation.


In the 1991-92 session, five House bills and one Senate bill employed census data in their formulation. For 1993-94, seven House and five Senate bills were identified, and for 1995-96, there were eight House and four Senate bills. The 1997-98 session found fourteen House and three Senate bills with census data language. Thus far in the 1999-2000 session, there have been fourteen House and four Senate bills.

The types of data required in these bills were primarily population and poverty statistics. Most bills looked at the total population of areas while others required details such as rural population or population by age or race. The data was to be used for two primary purposes. The number one use was for funding allocations and the second was for determining salaries for local officials.

Three of the bills identified in the 1997-98 session became law. Act 79 affects jury commissioners in counties in a specific population range. Act 152 creates a statewide committee for the protection of senior citizens. And Act 92 creates Keystone Opportunity Zones to foster economic opportunities and facilitate economic development.


Decennial Census data is used in federal funding streams to states. According to the 1999 Consolidated





Federal Funds Report by the U.S. Census Bureau, \$82.2 billion came to Pennsylvania from the federal government. Pennsylvania State Data Center analysis of these allocations revealed that approximately 11.5 percent or \$9.5 billion were distributed based on census data. Much of the total funding, however, comes in the form of salaries and wages, procurement contracts, retirement and disability, insurance, and loans. Excluding these amounts, the grants and direct payments total \$30.9 billion, and those based on census data account for 30.7 percent. This calculates to about \$791 for every person in the Commonwealth in 1999.

The Data Center has identified 22 main programs with these funds attached including the Job Training and Partnership Act, Head Start, and Community Development Block Grants. Sectors that receive allocations range from transportation to education to energy. Medicaid is the most highly funded.
