Mobile Homes in Pennsylvania

MIDDLETOWN, Pa – Recent media reports indicate that developers across the U.S. are purchasing trailer parks and replacing them with strip malls, townhouses, condominiums and big box stores. As affordable housing dwindles, states and counties are taking notice of their low-income mobile home residents.* Data from the 2004 American Community Survey (ACS) provides a picture of Pennsylvania's mobile home communities and can answer important questions like: what are the characteristics of the commonwealth's mobile home residents, and who will be affected by this trend in our state?

Affordable Housing

Mobile homes are an affordable housing alternative for low-income families and individuals. In 2004, the median value of mobile homes in the commonwealth was \$27,455, considerably less than the median value of all owner-occupied housing units (\$116,520). Mobile homes also stay more affordable over time. Since 2000, the median value of all owner-occupied housing units has increased by \$21,720, but the value of mobile homes has risen by just \$3,055. Affordability may also be reflected in the higher ownership rate of mobile home residents, 80.3 percent versus 72.5 percent for all other structures. There were 159,181 owner-occupied mobile homes in 2004 valued at \$6.1 billion, about 1.1 percent of the total value of owner-occupied housing units in the state. Since 2000, the number of owner-occupied mobile homes has declined by 16,050, or 10.1 percent.

More than 39,000 mobile homes were rented in 2004, about 3.0 percent of all renter-occupied units. Rent was less of a burden on household income for mobile home residents, accounting for less than 20 percent of household income in 31 percent (12,130) of mobile homes (Table 1). Gross rent of mobile homes averaged \$353, \$266 less than all other renter-occupied housing units.

Resident Characteristics

In the majority of mobile home residences in Pennsylvania, the householder who responded to the American Community Survey was White alone (195,849, or 98.7 percent), followed by persons of two or more races (1,246, or 0.6 percent), Black alone (673, or 0.3 percent), American Indian or Alaska Native alone (383, or 0.2 percent), and persons of some other race (213, or 0.1 percent). No Asians lived in mobile homes, and



due to the small sample size, no data was available for Native Hawaiian or Pacific Islanders. Persons of Hispanic or Latino origin, who can be of any race, accounted for 1,694 or 0.9 percent of mobile home householders.

More than 82,000 mobile home households were made up of married couple families, 37,005 households were single parent with no husband or wife present, and 80,092 nonfamily households were reported in mobile homes. Grandparents caring for grandchildren under 18 lived in 2,840 mobile home households.

Vacant Mobile Homes and All Other Types of Units

Some 51,000 of the 249,493 mobile homes and all other types of units were vacant in 2004. More than 5,600 were for sale or rent, and 26,958 were kept for seasonal or recreational use. Almost half of all mobile homes in Pennsylvania were built between 1960 and 1979. Nearly two-thirds have 4-5 rooms, and 84.4 percent have at least 2 bedrooms. Twenty-eight percent (14,316) lack complete plumbing facilities, and 14,336 lack complete kitchen facilities.

More on the American Community Survey

Most of the data in this brief is from the 2004 American Community Survey (ACS). ACS, which has already begun a phased rollout, will replace the census long form currently collected every 10 years and provide yearly socio-economic data. The 2004 survey was confined to population areas of 250,000 or greater and did not include group quarters. Group quarters are living quarters in which unrelated people live or stay other than the usual house (for example, college dormitories, military barracks, prisons, and nursing homes). Beginning in 2005, ACS will include group quarters and expand to areas of 65,000 or greater.
