2013 Annual Data User Conference to Discuss Data Visualization, Municipal Financial Distress and Much More

PENN STATE HARRISBURG – Data users from across the Commonwealth are set to gather at the Holiday Inn Harrisburg/Hershey for the Pennsylvania State Data Center's 2013 Annual Data User Conference on September 19, 2013. The Annual Data User Conference serves as Pennsylvania's most comprehensive single-day forum for research and development in demographic data.

This year's conference entitled, *Making a Difference with Data*, will center on the importance of demographic and socioeconomic data in the areas of planning and decision making for various statewide and community initiatives. A unique array of sessions by researchers, geographers and state leaders will discuss topics like the utilization of data technologies and resources and their application to public policy and community development.

Conference attendees will also be brought up-to-date on the latest from the U.S. Census Bureau, including the release of the 2012 Economic Census data, the new Geographic Support System Initiative (GSS-I) for the 2020 Census, and the sample size changes with the American Community Survey.

Data Visualization in a Digital Workplace

Effective data visualization is an important tool in the decision making process. In the Keynote Address, Lee Ann S. Labecki of KPMG will discuss the increasing importance of data visualization in today's workplace and the value of understanding the cognitive processes that underlie effective digital dashboard development and design.

Ms. Labecki is a seasoned policy and research professional with nearly three decades of public and private sector executive management experience. Prior to joining KPMG, Ms. Labecki was Director of the Office of Research, Evaluation, and Strategic Policy Development at the Pennsylvania Commission on Crime and Delinquency. She has authored and co-authored numerous articles for professional trade journals and has been a guest speaker at national, state, and local conferences and workshops.

Financially Distressed Municipalities and Impacts of Shale Drilling

Shippensburg University researcher, Dr. Patricia Patrick, is set to present her analysis of municipalities experiencing financial distress between 2007 and 2010. The various demographic, economic and financial data and the criteria established by the Municipalities Financial Recovery Act that categorize municipalities as financially distressed will be presented. Dr. Patrick will also discuss the findings, including urban/rural differences and trends in the number of distressed municipalities over the period.

Dr. Mark Price of the Keystone Research Center and Michael Wood of the Pennsylvania Budget and Policy Center will discuss the first part in a series of reports on the impacts of Marcellus Shale drilling. The presentation will examine the social and human service impacts of drilling by exploring its effects on housing, emergency services, crime, health care services and much more. The session will delve further into the matter by also discussing the steps that local governments have taken to mitigate such impacts.
